The anti-ragging committee has a diverse mix of membership in terms of level as well as gender. The anti-ragging squad comprises of heads of department, senior faculty and staff of the college. If the Committee finds the merit in the case of ragging on the complaint received, the Committee will take immediate action including the filing of First Information Report (FIR) with the local police depending on the seriousness of the case.

Anti-Ragging Squad

Anti-ragging squad is also formed in the college to keep vigil in the college premises and submit recommendations to the Anti Ragging committee as and when required. The squad make surprise visits to canteens, common places to check any junior students are being ragged by seniors.

Anti-Ragging Policy

GIT community is aware of the fact that prevention and prohibition of ragging in institutions imparting higher education in the country is a great concern of all authorities including the law enforcing agencies. Regulations have been framed by various apex bodies of higher education in the country in order to root out ragging in all its forms in the Universities and its affiliated colleges across the country. In this context, as per the directions of Hon'ble Supreme Court it is mandatory for the college to implement the following.

- The punishment must be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents and exhibits the zero tolerance against the act of ragging.
- Every single incident of ragging where the victim or his parent/guardian or the Head of Institution is not satisfied with the institutional arrangement for action, a First Information Report (FIR) must be filled without exception by the institutional authorities with the local police authorities. Any failure on the part of the institutional authority, or negligence, or deliberate delay in lodging the FIR with the local police shall be construed to be an act of culpable negligence on the part of the authorities by the Courts. All efforts should be made to ensure that cases involving ragging are taken

up on priority basis to send the message that ragging is not only to be discouraged but also to be dealt with sternness.

Hence, it is emphasized that ragging of and among students of GIT in any form at any place will not be tolerated, and it is banned. For this purpose, the following activities and / or actions shall be construed as the forms of ragging.

- Ragging has several aspects among others, psychological, social, political, economic, cultural, and academic dimensions.
- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other students.
- Indulging in rowdy or undisciplined activities by any student or students, which causes or is likely to cause annoyance, hardship, physical or psychological harm, or to raise fear or apprehension thereof in any fresher or any other student.
- Asking any student to do any act, which a student is not comfortable or has the effect of causing or generating a sense of shame or torment or embarrassment to adversely affect the physique or psyche on such fresher or any other student.
- Any act that prevents disrupts or disturbs the regular academic activity of a student.
- Exploiting the services of a junior student for completing the academic tasks assigned to an individual or a group of seniors.
- Any act of financial extortion or forceful expenditure burden put on a junior student by senior students.
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults and stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health of the student.
- Any act or abuse by spoken words, emails, snail-mails, blogs, public insults, including deriving
 perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the
 discomfiture to others.
- Any act that affects the mental health and self-confidence of students.
- The human rights perspective of ragging which involves the injury caused to the fundamental right to human dignity through humiliation heaped on junior students by seniors; often resulting in the extreme step of suicide by the victims.

Any student of GIT found indulging and / or abetting any form of ragging shall be meted out with exemplary and justifiably harsh punishment including debarring such students from taking admissions in any institutions of higher learning in the country. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the college, the possible punishments (one or a combination of more than one) for those found guilty of ragging at the college level is as follows:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process Withholding results
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/expulsion from the hostel.
- Rustication from the college for a period as may be determined by appropriate authority.
- Expulsion from the college and consequent debarring from admission to any other institution of the college.
- Fine of Rupees 25000/-
- Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

All the students of GIT are advised to abide by the instructions scrupulously to ensure a healthy academic atmosphere and make it a ragging free campus. Strict observance of the instructions and cooperation with the college in its efforts to ensure a "Ragging Free Gregorian Institute of Technology" is highly solicited.
